



Wrap It Up

This is our annual December all-member, small works holiday art show and take-it-off the wall sale. It is not juried.

Submissions: Each CHAL member may submit four pieces, three of which will be hung initially, and the fourth will go up in the event a work is sold and taken from the wall. (Sales were strong last year-over 50 pieces flew off the walls).

The receiving fee is \$5 for one piece, \$8 for two, and \$10 for three or four. The framed size of any piece submitted cannot be larger than 16 x 20. Artists are encouraged to think "gift priced" when pricing their work for this show, and receive 70% of any sales.

Receiving will be Saturday, December 3 from 9:30-1:30 and Monday, December 5 from 9:30-11:30 am.

The opening will be on Friday, December 9 from 6:30-8:30 pm and on Saturday, December 10 from 5:00-7:00 pm. Artists are asked to bring beverages (wine, soda or water) on Friday if they are attending that night, or appetizers (fun and fancy finger food) on Saturday night.

Postcards will be available at the CHAW desk advertising the event. Stop by and pick some up to share with friends, family and coworkers. Or you can pass along the attached Acrobat file as an email invitation.

The show will be closed during the holiday break from Christmas through New Years. Please pick up your unsold work either prior to the break or after the new year.
