Notes from November Juror Brenda Belfield

"What I look for when jurying an exhibit is the overall impact: what engages me immediately as a creative innovative work. Those who paint or photograph beautiful subjects such as flowers and landscapes have the difficult task of presenting the subject in a way that hasn't been seen before or painted before by many artists. Most jurors have seen thousands of paintings over a lifetime, so there is an immediate recognition of typical paintings or familiar subjects.

Those artists who have a unique vision, who can show us a subject that we have not seen before or present an ordinary subject in an extraordinary way, will attract a juror's eye. In addition to subject matter, an unusual color combination or composition will attract a viewer. The surface quality and the way the artist handles the media is also very important as it shows the technical proficiency of an artist. The presentation of the art, framing appropriate to the style of the art work, is the final element that enhances the work. The artist who can consider all these factors will create a work that I call "ART."

Brenda Belfield has numerous and diverse accomplishments. She founded ARTWORKS Gallery and Studio in Reston in February 2004. From 1983 to 1996 she served as a director of the National Board of the Interfaith Forum on Religion, Art, and Architecture. She has taught art in the Fairfax County Schools and currently teaches at the Art League School and in her Reston gallery. Her abstract painting ability has been recognized in 11 one person shows. Sixty stained glass windows at the National Cathedral were designed by Brenda and she has received six national awards for her glass designs. A NATO base in Sicily has a Belfield wall of marble and glass. Brenda's classes and ARTWORKS programs are designed to teach people to see and think in new ways. She is currently planning for a juried group of artists to exhibit and explore the creative process. For more information about Brenda, visit: BelfieldArtworks.com.

Win: The winning logo design will be announced at the show opening on Saturday, February 9th, 2008. A \$100 award will go to the winning entrant.

File & Design Requirements:

• Your submission MUST be an electronic file: tiff, jpeg, or eps and a minimum of 300 pixels per inch at 5 inches wide. (If you wish to create your logo freehand, businesses such as Kinkos, Ritz Camera and Staples provide scanning services).

• The logo must include the words Capitol Hill Art League.

• Must look good in black and white as well as in color, and for both screen and print (RGB vs. CMYK).

• Must scale up/down depending on use (the design must work on everything from buttons to posters).

• All submitted designs must be original and not based on any pre-existing design. If your entry producestrademark problems due to potential similarities to existing trademarks it will not be considered.

• By entering a logo design you agree to transfer the copyright of the design to The Capitol Hill Art League should your design win.

• The winning concept may be further developed by our creative team as needed to achieve the goals of CHAL.

January Juror is Mark Power

Our Juror for the January show, "Night and Day" is Mark Power. Mark was educated at Bowdoin College , American University, and the Art Center College of Art and Design. He was a professor of photography at the Corcoran College of Art and Design, for 27 years and currently teaches a course called 'Beyond the Image' at Photoworks, in Glen Echo, MD. His photography exhibitions include those at the Corcoran Gallery of Art in Washington, the Virginia Museum in Richmond , Virginia , the Kathleen Ewing Gallery in Washington DC and many private galleries throughout the United States. His work has shown in Paris, London, and Norwich, England and is in many collections including those at the Library of Congress, The Smithsonian, the Corcoran Gallery of Art, and museums in Baltimore , Houston , New Orleans , and Richmond.

Power wrote art criticism for the *Washington Post* for four years and he has contributed over 100 articles on photography and art to a variety of other publications, including *Photo Review, Art in America* and the *Times Literary Supplement* in London. He is the author of four book introductions and is currently a contributing editor at Photo Review. Mark recently returned from a five year stay in the United Kingdom and now lives in Silver Spring , Md . He has four daughters (one of whom is the novelist Nani Power) a son, and six grandsons. He is married to Virginia C. Power, a museum specialist at the Natural History Museum in Washington .
