The names of the interested artists will be e-mailed to the membership during the first week of April, and their statements will be available at the front desk of the Workshop, so you can check them when you deliver your work for receiving. To help you plan, note that anyone elected will probably have to attend only one or two meetings over the summer, and that your service would begin in October 2004. The Steering Committee will meet in the evenings if that proves most convenient for members.

SUBMISSIONS

The Holiday Show was a tremendous success. Members submitted 109 pieces, and a third of them sold. Most of the buyers were looking for gifts, so the less expensive pieces flew out the door. When people were buying a more expensive art gift (priced between \$100 and \$250), the whole package, particularly the framing, had to be perfect. Please begin to think about work for the next Holiday event, in December 2004.

So far this year, submissions of works for shows are running at about at the same rate as last year. In October of 2002 we had 65 submissions, of which 35 were accepted. In November of 2002, we had 92 submissions, but only 81 in November 2003. This January's submission rate was "sluggish," but February's was good. Please keep those pieces coming in!

WORKSHOPS

The Art League has sponsored two excellent and well attended workshops so far this season, one involving watercolor and the other collage. We hope to do more of this and welcome members' suggestions for topics for future workshops. We will sponsor a workshop by artist Susan Abbott (see her website at www.susanabbott.com) on March 19 from 10 am until 4 pm. The subject will be color. OPENINGS

Please keep in mind that our openings are on the second Saturday of each month, from 5 to 7 pm. We try to introduce the speakers/ judges at about 5:25 pm so that you can plan your time there.

Also, please pick up your work as soon as

you can so that the storage space at CHAW does not get over-crowded and to minimize the possibility of something getting damaged. Returned work from Skadden Arps will also be located in the closet, on the side marked "old work."

SHOULD WE DO AN AUCTION?

In years past, the Art League occasionally held fund-raising auctions of art works donated by the members—something like the Patrons Show at the Alexandria Art League. The auctions were held outside the Workshop, and the evenings were festive, with refreshments and door prizes in addition to the drawings. Tickets were sold all over Capitol Hill. The buyers' names were written on slips of paper and placed in a large bowl. As each name was drawn, that person was allowed to choose whatever piece he or she wished from among those still hanging. It is a wonderful fundraiser and generates great publicity for the artists and the Art League. So, the question is: Should the Art League do this again in the 2004-2005 season? We will discuss this at the Potluck.

A NEW OPPORTUNITY TO SHOW

In December 2003, the Art League entered into an arrangement with Skadden Arps, a downtown law firm, under which we will lend them paintings on a short-term basis for them to hang in their offices and offer for sale. For starters, we lent them 13 paintings and photographs to hang. One piece sold.

Hereafter, we will send Skadden Arps one piece from each artist juried into alternate Art League monthly shows. Each of the artists will be asked by e-mail or phone whether they wish to participate. Thus, most of the juried January show was transported to Skadden in early February, and will remain on display for about seven weeks. It will be replaced by works juried into the March show.

We will try this arrangement for the remainder of this season, and then consider how to handle it in the future. Please bring any thoughts you have about it to the Potluck for discussion. Skadden Arps is very cooperative with us, but it is a high security organization, so it is not possible for members to drop by or send friends to visit the show.
