

CHAL Exhibit Opportunities at Results Gym

Results Gym, 315 G St SE, Washington, DC 20003, is housed in the J.R. Giddings School, originally built in 1889. It is considered a historically significant building due to its role as the first all-black public school in Washington, DC. Surplused and sold by the DC government in the late 1990s, Results Gym fully renovated the building into a 65,000 sq. ft. multi-use fitness facility and opened September 2001. It is a very popular gym on Capitol Hill.

Ten to twelve Capitol Hill Art League (CHAL) artists have the opportunity to exhibit six to ten pieces of their two-dimensional art at the gym in two month exhibit cycles. Artists handle sales directly without any commission being collected. The space can accommodate various sizes of work from very large to rather small, and work previously accepted into CHAL shows can be included, because this is not a juried exhibit. No nudity or art with an overtly political message can be shown. Artists are encouraged to provide bio and printed artists statements that can be displayed along with the art.

Results Application Process

- 1. Sign up to exhibit at Results through Smarter Entry for \$25. To submit your registration with payment go to https://client.smarterentry.com/CHAL To speed up the process, do **not** include jpegs of your art work. **Make sure** to note in your registration which exhibit you want to be in see schedule below. CHAL will collect a \$25 fee to participate in the Results exhibit.
- 2. CHAL Steering Committee member Hamid Lagder will notify artists if they are in the exhibit and who will assist them at Results during installation. Artists must hang their own art work or arrange for a substitute person to hang their works. This also applies to the strike day when artists must remove their own art pieces or arrange for a substitute to remove their works. If the participating artists are interested in hosting an opening, the artists will be responsible for planning, hosting and paying for the opening reception. CHAL will help in publicizing the event.
- 3. Artist prints own labels (and artist statement/ bio sign if they choose). Labels must include contact information of phone number and/or email address for buyers to contact the artist about sales.
- 4. Artist handles all sales, and there are no commissions. Art sold during the period of the show can be taken from the wall at the time of the sale as long as the artist can meet the buyer

and replace the piece on the wall. **Results Gym cannot and will not handle any sales for the artists**. Sales must include the 5.75% DC sales tax, and the artist needs to submit the tax to the city revenue office.
