Your road might be a back alley, a highway to heaven, or a yellow brick one. Cross-country or across the street, it's time to hit the road. This CHAL members exhibit is open to 2-d and 3-d work and all mediums including sculpture.

Receiving Dates: Please bring ONE finished artwork ready to hang with proper wiring to CHAW on Saturday, Sep. 7, or Monday, Sep. 9, from 9:30 to 11:30am. Please label your work with your name, title, medium, and price.

Entry fee: \$5.00 payable when you drop off your artwork.

All work must be original and signed by the artist. Any work previously shown at a Capitol Hill Art League juried exhibit is ineligible. All work must have been created within the last three years.

People's Choice Award: Voting for People's Choice Award will take place during the opening reception on September 14, from 5 to 6:30pm and announced by 6:45pm. Winner does not have to be present for voting/announcement.

Sales: A 25% commission on all exhibition sales is deducted by CHAW from the pre-tax sales price. All work must be for sale, and the price submitted on the registration form will be the price presented at the time of the show for accepted work. Prices cannot be changed once you submit your work.

All sale payments to CHAL members are processed electronically via direct deposit to the artist's bank checking account. Members who sell artwork will be requested to mail or email a vendor information form (to be supplied when a sale is made), to Nicholas Peterson, CHAW's accountant. Direct deposit will appear within two weeks of the payment request form being received by CHAW.

Size limits: The size of wall-hung work must be no larger than a maximum of 48 inches in either direction and 30 lbs. Any piece larger than 20x24 should have Plexiglas (not scratched) and a sturdy frame. Insurance is <u>not provided</u>. 3D pieces must fit on pedestals that are 12"x12"; no 3D work can be installed on the floor.

All work must be ready for display. All two-dimensional work must be properly matted and framed; no clip frames will be accepted. All 2D work must have hanging wire securely fixed to the back. Any pieces delivered that are not exhibition-ready with proper framing, hanging wires, etc., or are without bases for 3D work will not be juried or exhibited.

The artist is responsible for any insurance on his/her work during the exhibition. (The utmost care is given to all entries, however, the Capitol Hill Art League and the Capitol Hill Arts Workshop do not assume any liability for damage or loss before, during or after the exhibition.) Further information will be sent to the artists whose work has been accepted.

The Capitol Hill Art League (CHAL) is a program of the Capitol Hill Arts Workshop. Located in the historic Capitol Hill neighborhood in Washington, DC, CHAL is composed of approximately 60+ artists. Each season CHAL mounts a series of juried exhibitions, both at CHAW and at external venues, with gallery talks at the openings.
